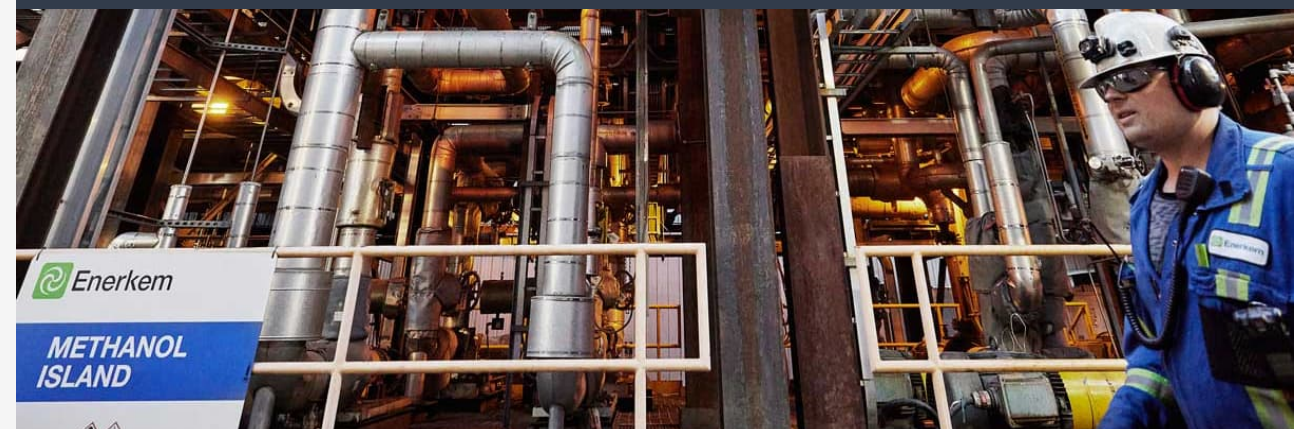

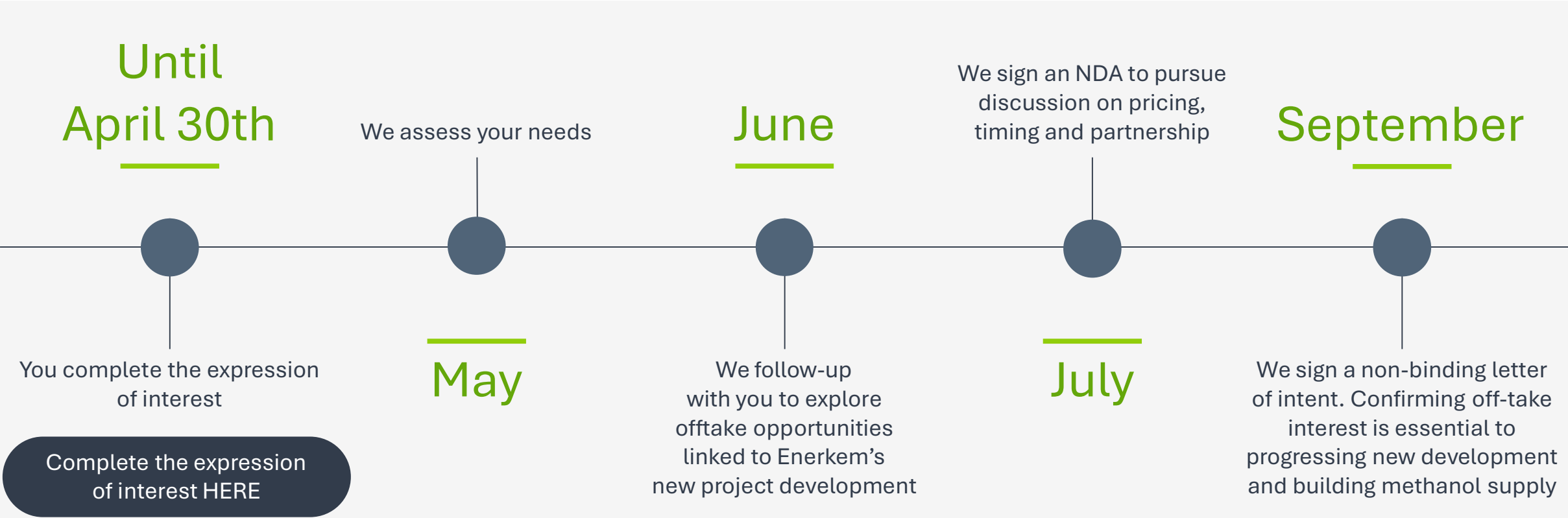

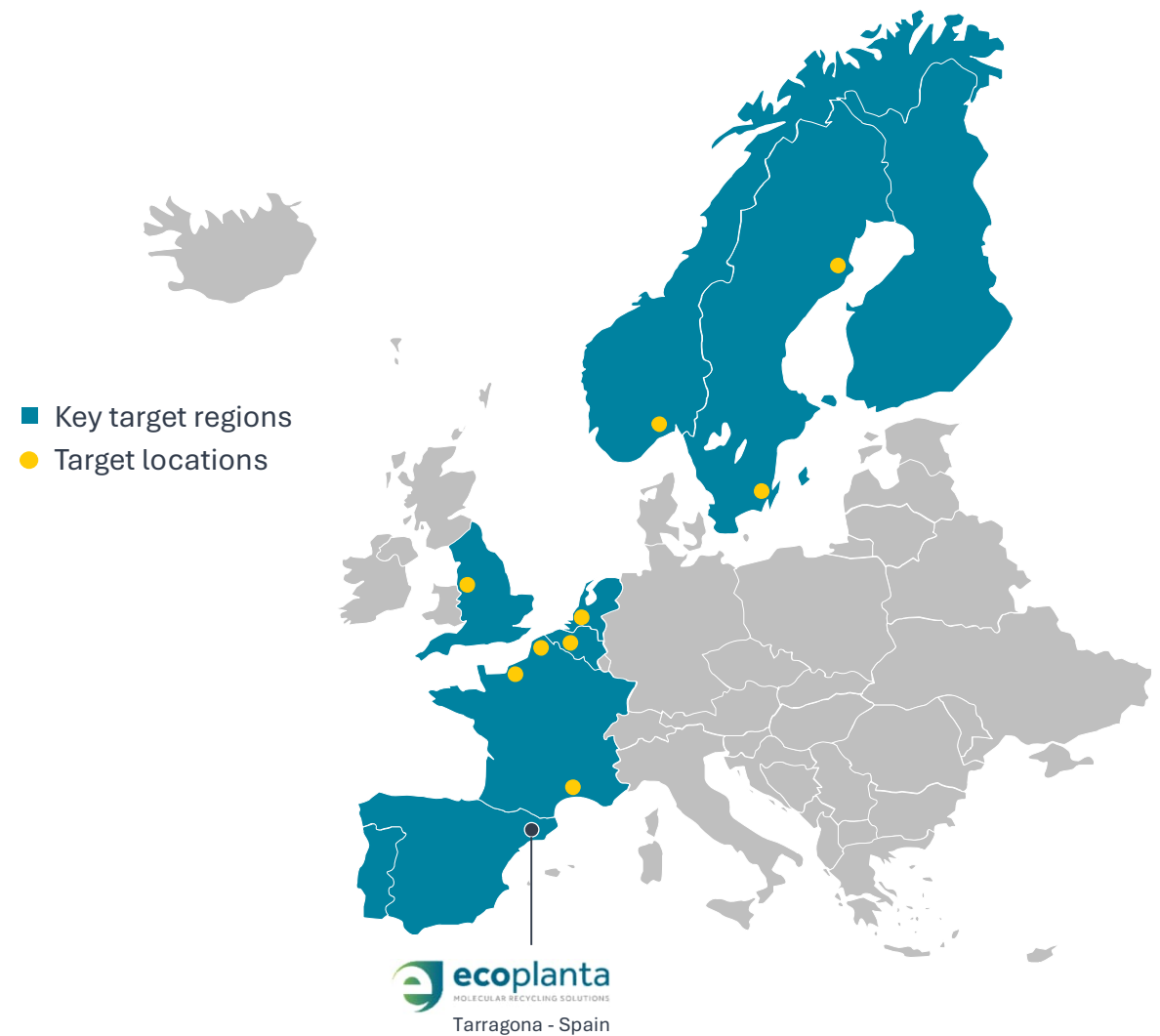
New project locations

➔ Open to exploring other locations of your interest

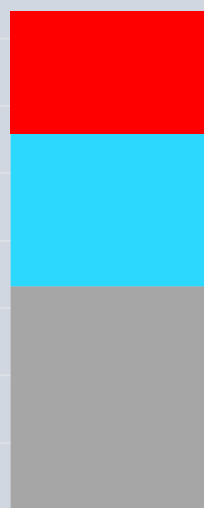

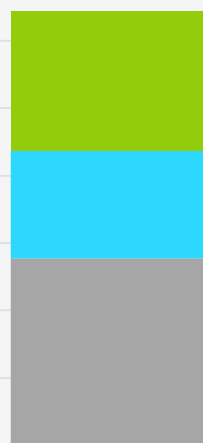

■ Fossil fuel ■ EU ETS ■ Fuel mandate penalty ■ Enerkem's sustainable methanol

- Transition fuels can aid in achieving short-term regulatory compliance
- Longer term compliance will require sustainable fuels in addition
- Supply of low carbon fuels constrained and will remain so given high demand
- Price setting mechanism therefore likely to remain non-compliance cost
- Our sustainable methanol can deliver significant cost savings
- Entering into long-term off-take agreements offers security over supply
- Opportunity to benefit from falling production costs over time
